**Flexi-Van Leasing, Inc.** is pleased to announce that **Pacific International Lines (PIL)** has confirmed that they will no longer supply chassis for Merchant Haulage shipments in FLBP (Pool of Pools) beginning January 1, 2016. Chassis for **Pacific International Lines (PIL)** Merchant Haulage shipments in FLBP will be supplied by, and usage will be billed by, Flexi-Van Leasing.

We encourage all Motor Carriers who participate in FLBP to take this opportunity to register as a User.

**NOTE:** If you are already registered and approved for FLBP (formerly the LABP and also known as the Pool of Pools), you do not need to register again or do anything additional for the Pacific International Lines (PIL) transition.

By becoming a registered Motor Carrier in FLBP, you will benefit from a seamless transition of chassis supply from Ocean Carrier provided chassis to Motor Carrier and Shipper provided chassis.

**To Register:**

- Click the Register button next to “Not Registered Yet?” on the **Pool Chassis** page
- Follow below Steps 1 through 4 to complete the application and submit your request

**Step 1:** Enter SCAC code to be verified against NMFTA (National Motor Freight Traffic Association, Inc.)

**Step 2:** Select Pool – FLBP Flexi-Van Los Angeles Basin Chassis Pool - and complete your Account Information

**Step 3:** Read and acknowledge the **Flexi-Van Leasing, Inc.** (INTERMODAL) Chassis Interchange Agreement. (A link to download the Chassis Agreement, Insurance Requirement documents and Credit Application documents will be provided.)

**Step 4:** Confirmation email will be sent with Instructions & requirements from **Flexi-Van Leasing, Inc.** (INTERMODAL).

Once registered and credit/insurance are satisfied, you will be eligible to utilize the pool chassis as an approved user, and as the transition progresses over the next few months from Ocean Carrier Supply chassis to Motor Carrier, you will be ready to take advantage of the market by being prepared for the

transition. By being prepared you should see limited delays and service disruptions as the transition takes place. Additionally, you will receive a User Id and Password to review the transactions specific to your chassis activity as a participating Motor Carrier in FLBP, and will be able to review and pay your invoices online via our Online Payment Portal.
